Francesca became the first ever Maltese tennis player to reach a Final of a 'Futures' event. Unfortunately she was beaten by her Polish opponent in the final.

Francesca has been playing tennis since she was seven and since then she participated in international tennis tournaments across the globe making quite a name for herself on the world junior circuit having taken part in all the junior grand slams - Roland Garros, Wimbledon, US Open and Australian Open.

With international more matches on her calendar this year, Francesca Curmi will not be returning to Malta for some weeks. Therefore the official presentation

of the Atlas Youth of the Month trophy and the sports apparel voucher that goes along with this award will be held at a later date.
