Club News

Dear members,

AGM 2024

We held our AGM 2024 on the 26th January 2025 at the 1743 Razzett L-Antik in Qormi.

For the benefit of those who could not join us for the AGM, I will give you a brief resume' of what was discussed and agreed at the meeting:

The Agenda for the AGM was:

- 1. Opening of Meeting
- 2. Hon Secretary Report
- 3. Hon Treasurer's Report
- 4. Changes to the Club Statute
- 5. Election of the Club Committee for 2025/2026
- 6. Other Matters

The Commodore, Johann Cuschieri opened the meeting at 11:00 am followed by a detailed report from the Hon Secretary of the events organised by the Club during 2024. This was followed by a report by the Hon Treasurer of the finances of the Club for 2024.

Changes in the Statute of the Club and Membership Fees

The fourth item of the agenda was a proposal to make changes to the Club Statute to conform with the Voluntary Organisations legislation regarding the review or audit of an organisation's annual financial statements. The changes were suggested to us by the Office of the Commissioner for Voluntary Organisations and they were approved by those present at the meeting.

Election of Club Committee for 2025/2026

We have circulated proposal forms to all members for the six vacant seats in the Committee for the two years 2025/26. The closing date for nominations for members to propose themselves for the Club Committee was the 11thJanuary 2025.

By that date, we received eight (8) duly filled in Nomination Forms; so, a vote was taken to select 6 members to stand for the Club Committee. The number of eligible members who could vote during the AGM were 38 and the elected members were: **Nicholas Attard, Austin Calleja, Chris Sciberras, Victor Taliana and Claude Vella**. Candidates Pierre Aquilina and Patrick Genovese obtained the same number of votes and according to Clause 7.10 of the Club statute (which states that "*In the event of a tie the election shall be settled by drawing lots by the Electoral Commissioners*") the lots fell on **Patrick Genovese** who became the sixth member of the Committee.

Subsequent to the AGM, the six elected members to the Committee of the Club met at a Committee Meeting on Thursday 20th February 2025 and decided that the officers of the Club shall be:
